1. **Himali Rural Municipality Office of Rural Municipal Executive Dhulachaur Bajura** invites electronic bids from eligible bidders for the construction of **Construction of DhimPandi Road Construction Work** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs3,00,00,000.00**
- Minimum Work experience of similar size and nature: **(Construction of Road including Hard Rock Cutting And Himalayan Range Cutting)1,60,00,000.00**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

3. Bidder must chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .



4. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **31 Dec 2021**, Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00** on **31 Dec 2021** at the office of **Himali Rural Municipality Office of Rural Municipal Executive Dhulachaur Bajura**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **5,50,000.00** which shall be valid for 30 days beyond the validity period of the bid
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
