 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on May 25, 2021 at the office of Himali Rural Municipality, Bajura. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security. Which bid security shall be valid for 30 days beyond the validity period of the bid.
 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

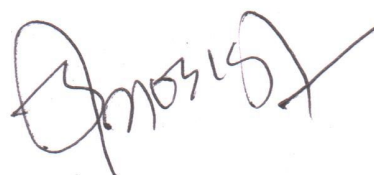

Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security. Which bid security shall be valid for 30 days beyond the validity period of the bid.
